When you drop off your completed entry form and your miniatures at the registration table, you will be issued a numbered ticket. To collect your miniatures at the end of the show, you must present this ticket **along with valid ID**. Miniatures will be returned only to the person who entered them.

Each entry is eligible to win a gold, silver, or bronze medal in its category based on its own merit. Multiple gold, silver, and bronze medals may be awarded in each category.

From the gold winners in each category, four Best of Category winners will be chosen, from which the Grandmaster will be chosen. The Grandmaster winner will receive a \$500 credit. The remaining three winners will receive a \$200 credit.

In order to compete, all contestants must read and agree to the rules on the following page. By entering this contest and signing below, you agree to these rules and to the terms of this agreement.

Specific Rules

All entries must be Privateer Press miniatures. Conversions and scratch-building are allowed but must fall within the scope and atmosphere of the Iron Kingdoms. Resin bases and hobby miniature terrain accessories are allowed; terrain accessories can include, but are not limited to, brass etched parts, resin columns, grass tufts, flock, and pre-made trees made by third-party companies who do not market and/or produce tabletop miniature games. Entries containing terrain or accessories from other miniature gaming companies will be disqualified.

All entries must be modeled and painted by the entrant. Contestants must submit their miniatures in person at the specified time. After the competition, entries must be collected from the display area at the specified time. Any entries not collected by 4:00 p.m. on June 23, 2019, will become the property of Privateer Press.

All entries must be accompanied by an official entry form that is filled out clearly, completely, and correctly. Each entrant will receive a numbered ticket. In order to collect miniatures at the end of the show, each competitor must present this ticket in person along with a valid form of identification.

Contestants can enter a specific category up to three times, and they may enter as many of the categories as they choose. For example,

one competitor cannot enter five different models in the Massive Model category but can enter different models in the Single, Monsterpocalypse, and Massive categories.

All entries except those presented as part of a diorama must be mounted on a display base or a gaming base. If a model is mounted on a gaming base, it must be a Privateer Press base of the appropriate size.

While all entries will be handled as carefully as possible, Privateer Press will not be responsible for any damage or loss that might occur while contestants' miniatures are in our care.

Privateer Press has the right to photograph entries and to publish any such photographs on the Internet or in print.

Privateer Press reserves the right to refuse entry to any competitor, with or without cause.

Privateer Press staff and their family members are not eligible to enter this competition.

Cash winnings are subject to all state, local, and federal laws. Payments will be made by check in U.S. dollars.

The judges' decisions are final in all cases.

GENERAL CONTEST RULES

Privateer Press, Inc. (hereafter known as Privateer) does not require contestants to make any purchase during the convention in order to be eligible for entry.

Privateer contests and promotions are not open to current employees of Privateer, its subsidiaries or agents, or co-sponsoring participants, nor to immediate family members or household members of those employees.

When a contest or promotion requires on-site registration, all entries must be completed in person at the registration point. Entry blanks may not be removed from the registration point and returned later. Participants may enter only once per event or category. Anyone found entering more than once will be disqualified.

All contest participants must be at least 18 years of age, or in some cases 21 years of age. If a minor wins a Privateer contest or promotion, the prize may be awarded in the name of a parent or legal guardian.

Valid state identification, such as a driver's license, is required to participate in any Privateer contest or promotion or to claim a prize. In order to claim prize(s), winners must to show proof of identity and may be required to execute an affidavit of eligibility release/prize acceptance form and a W-9 tax form.

Contestants must use their true legal name and address when participating in a Privateer contest or promotion. Contestants who fail to do so will be disqualified and will forfeit any prizes won.

Privateer will designate judges for each promotion or contest. In the absence of a specific named judge, an employee representative of Privateer will be chosen. Contest judges will determine the winner(s) in all contests and promotions. All decisions made by the designated judges are final. By participating, contestants agree to be bound by all contest rules and by the decisions of the judges.

Privateer will not be responsible for lost, delayed, misdirected, damaged, incomplete, illegible, or postage-due mail entries, whether caused by equipment failure, technical problems, human errors, or acts of God or Thamar.

Participants waive any and all claims of liability against Privateer and contest sponsors, as well as their affiliates, employees, agents,

families, and household members, from any accident, loss, and/ or injury occurring as a result or consequence of participation in contests or promotions and/or winners' acceptance or use of prizes awarded at such contests and promotions.

Winners assume any and all tax liabilities that may be applicable to the claiming of prizes over a certain value. In other words, contests and promotions are subject to all applicable federal, state, and local laws and are void where prohibited or restricted by law.

Privateer will issue a 1099 tax form for all prizes valued at \$600.00 or more, including multiple cash prizes to the same winner adding up to \$600.00 or more over the course of a given year. By claiming a prize, the winner agrees to accept the estimate of fair market value placed on the prize.

All prizes will be mailed to the address supplied on the entry form unless otherwise arranged by head judge Ron Kruzie. Any other arrangements must be specified in writing and left with Mr. Kruzie. Winners must be present at the award ceremony to be considered for a prize. If a winner is not present at the award ceremony at the appropriate time to accept an award, a new winner will be chosen.

Privateer reserves the right to substitute prize(s) of equal or greater value.

Winners are solely responsible for insurance (when required), other prize-related expenses as may be specified, gratuities, and all applicable federal, state, and local taxes.

All entrants give Privateer Press the sole rights to all photographic and video recordings of the event, including recordings of figurines and of participants themselves in name, image, character, likeness, or voice, and in the fact that he/she participated in and/or won the contest. There will be no additional compensation for such images and recordings, and Privateer may use them at any time for any purpose.
